A/B	Peaslee and Galbraith Lab Results	Total Fluorine Content (For more details, see the "Test Methods" Tab)
		No/Low F/Low F = Not likely to be treated with PFAS F = High Fluorine (Likely treated with PFAS)
C	Date Added to Database	Date that products have been added.
D	Manufacturer/Brand	Name of Manufacturer or Brand/Product Line
E	Type of Product	Single-Use Plates, Bowls/Soup Containers, Clamshell or Take-out Containers, (Multi-compartment) Food Trays, or Food Boats, Cups, Lids, Straws
F	Product #/SKU	Stock Keeping Unit (SKU) or other Production Identification Code. Information provided by purchaser or from manufacturer/retailer website or product packaging
G	Product Description	Description provided by purchaser or from manufacturer/retailer website or product packaging
H	Product Material Type	Information from manufacturer/retailer website or product packaging about the material from which the product is made
I	Size	Information of the size/fluid capacity of a product, when available
J	BPI Certified	Certified by Biodegradable Products Institute (BPI) as compostable. Products were marked "no" when the exact type was not listed on the BPI site. Note: Some BPI-certified products on the market may be fluorinated but as of Jan. 1, 2020, ALL BPI-certified products on their website are free of intentionally added PFAS (<100 ppm total fluorine)
K	CMA's Commercially Accepted Products List	Compost Manufacturing Alliance (CMA) certifies products to ASTM D6400 and D6868 standards and performs field disintegration in real world compost operations for its certification. CMA members and affiliates represent a facility-based network accepting compostables at their sites. As of January 1, 2021, all CMA certified products listed are free of intentionally added PFAS (<100 ppm total fluorine).
L	BioPreferred Mandatory Federal Purchasing	The BioPreferred Catalog contains products that meet mandatory federal purchasing requirements of a minimum of 72% biobased content for containers and tableware. This designation does not mean that a product is certified compostable. More information: https://www.biopreferred.gov/BioPreferred/faces/catalog/Catalog.xhtml
		MFP = Mandatory Federal Purchasing (Bio-based content self-certified by the manufacturer)
		LV = Voluntary Labeling (Bio-based content certified by a third-party laboratory)

If the manufacturer's suggested retail price was not available, we tried to gather information from one retailer (Webstaurant) for consistency. However, if a product was not available on Webstaurant, we gathered prices from at least two or three retailers to provide either an average or the price per unit range available.
